How Do We Know?

America's Foreign Born in the Last 50 Years

During the last 50 years, the foreign-born population of the United States has undergone dramatic changes in size, origins, and geographic distributions. This population represented about 1 in 20 residents in 1960, mostly from countries in Europe who settled in the Northeast and Midwest. Today's foreign-born population makes up about one in eight U.S. residents, mostly immigrants from Latin America and Asia who have settled in the West and South. The Decennial Census and the annual American Community Survey allow us to trace the changes in the foreign-born population over time.

Where they live

Foreign –Born Population as a Percent of State Population

1960

About two-thirds of all states had less than 5 percent foreign born

In 1960, the median age of the foreign-born population was 57.3 years

70 percent of the foreign born-resided in the Northeast and Midwest

2010

About two-thirds of all states had more than 5 percent foreign born

By 2010, the median age of the foreign-born population was 41.4 years.

67 percent of the foreign born resided in the West and South. In 2010, 27 percent of California's population was foreign born, highest in the nation.
